## **Pre-Con Meeting Minutes**

April 10, 2025

- 1. Contractor to submit schedule/mobilization phasing plan, copy of permit, etc.
- 2. Project Progress Meetings will be held minimally every two weeks. Swaysland will provide project agenda and meeting minutes moving forward.
- 3. Construction trailer and equipment will be delivered on site, Monday 4/21/2025 and Contractor will begin mobilization.
- 4. May 11<sup>th</sup> due date for all balconies to be free and clear of all personal belongings.
- 5. Contractor will provide 2 week look ahead schedules for the residents.
- 6. Scaffolding will be delivered on site Friday or the following week (approximately 8 towers to start).
- 7. Scaffolding will be mobilized along East elevation balconies to start.
- 8. Permit status pending submitted this week. Engineer requests copy of permit.
- 9. Balcony ceiling fans will be assessed by Swaysland if they need to remove, replaced, and/or protected and can stay in place.
- 10. Contractor will give a project on when the public walkways can be mobilized.
- 11. Garage work will likely start in May 2025 when the majority of residents have left. The BOD will request all residents leave a key. Work slotted for rainy day delays, etc.

- 12. Contractor to notify Association to move cars with the Property Manager a minimum of 48 hours in advance.
- 13.BOD would like mini mobile and/or POD storage containers option for residents. Hurricane shutters can be stored in parking garage in a couple empty spaces, etc.
- 14. Association mentioned to hurricane protocols and Swaysland reviewed hurricane preparedness notifications, etc.
- 15. Benjamin Moore paint color samples to be selected and painted in the garage in the garage.
- 16. Schedules will be tentative, weather permitting and updated with each payment application.
- 17. Blue plastic window protection to stay on for approximately 30 90 days.
- 18.BOD would like to know if public walkways re-coat waterproofing option could be available if full color change becomes unsightly.
- 19.BOD prefers not to paint gutters.
